Plaintiff Tiffany (NJ), LLC, a Delaware limited liability company (“Plaintiff” or “Tiffany”) hereby sues Defendants, The Partnerships and Unincorporated Associations identified on Schedule “A” hereto and Does 167-1000 (collectively “Defendants”), and alleges as follows:

JURISDICTION AND VENUE

1. This is an action pursuant to 15 U.S.C. §§ 1114, 1116, 1121 and 1125(a) and (d). Accordingly, this Court has subject matter jurisdiction under 28 U.S.C. §§ 1331 and 1338.

2. Venue is proper in this Court pursuant 28 U.S.C. § 1391, and this Court may properly exercise personal jurisdiction over Defendants since all Defendants directly target business activities towards consumers in Nevada and cause harm to Tiffany’s business within this District through various fully interactive Internet websites, including those operating under their partnership and/or business association names (the “Subject Domain Names”).

THE PLAINTIFF

3. Tiffany is a Delaware limited liability company, with its principal place of business in the United States located at 15 Sylvan Way, Parsippany, NJ 07054. Tiffany is, in part, engaged in the business of manufacturing and distributing throughout the world, including within this Judicial District, high quality luxury goods under multiple famous common law and Federally registered trademarks including those identified in Paragraph 13 below. Tiffany offers for sale and sells its trademarked goods within this Judicial District. Defendants’ sales of counterfeit Tiffany branded products are causing damage to Tiffany within this Jurisdiction. Tiffany regularly enforces its intellectual property rights and authorized that this action be brought in its name.

4. Like all other famous trademark owners in the field of luxury goods, Tiffany suffers ongoing daily and sustained violations of its trademark rights at the hands of counterfeiters and infringers such as the Defendants herein, who wrongfully reproduce and counterfeit Tiffany’s trademarks for the twin purposes of (i) duping and confusing the consuming public and (ii) earning substantial profits. The natural and intended byproduct of Defendants’ actions is the erosion and destruction of the goodwill associated with the Tiffany name and associated trademarks.

5. In order to combat the harm caused by the combined actions of Defendants and others engaging in similar conduct, each year Tiffany expends millions of dollars in connection with trademark enforcement efforts, including legal fees, investigative fees and support mechanisms for law enforcement such as field training guides and seminars. The recent explosion of counterfeiting

1 over the Internet has created an environment which requires Tiffany to file a massive number of
2 lawsuits, often it turns out, against the same individuals and groups, in order to protect both
3 consumers and itself from the ill effects of confusion and the erosion of the goodwill connected to
4 the Tiffany brand. The financial burden on Tiffany and companies similarly situated is staggering as
5 is the resulting burden on the Federal court system.

6 **THE DEFENDANTS**

7 6. Defendants are partnerships or unincorporated business associations which operate
8 through domain names registered with registrars in multiple countries including China and the
9 United States and are comprised of individuals and/or business entities of unknown makeup, many
10 of whom likely reside in the People's Republic of China or other foreign jurisdictions with lax
11 trademark enforcement systems. Defendants have the capacity to be sued pursuant to Federal Rule
12 of Civil Procedure 17(b). Defendants target their business activities towards consumers throughout
13 the United States, including within this Judicial District through the operation of the fully interactive
14 commercial websites operating under the Subject Domain Names identified on Schedule "A" hereto.
15 Multiple Defendants also operate blog style websites under some of the Subject Domain Names
16 which also provide support and direct customer traffic to the fully interactive websites operating
17 under the other Subject Domain Names. Defendants are directly and personally contributing to,
18 inducing and engaging in the sale of counterfeit products as alleged herein, often times as partners,
19 co-conspirators and/or suppliers. The partnership or business association names used by Defendants
20 are set forth on Schedule "A" hereto. Tiffany is presently unaware of the true names of Does 167-
21 1,000. Tiffany will amend this First Amended Complaint upon discovery of the identities of such
22 fictitious Defendants.

23 7. Defendants are the past and present moving and conscious forces behind the
24 operation of the commercial Internet websites operating under the Subject Domain Names.

25 8. Upon information and belief, Defendants engage in unfair competition with Tiffany
26 and the offering for sale and sale of counterfeit and infringing Tiffany branded products through
27 multiple fully interactive commercial websites operating under at least the Subject Domain Names.

1 Defendants, upon information and belief, also operate additional websites which promote and offer
2 for sale counterfeit and infringing goods under domain names not yet known to Plaintiff.
3 Defendants have purposefully directed their illegal activities towards consumers in the State of
4 Nevada through the advertisement, offer to sell, sale and shipment of counterfeit Tiffany branded
5 goods into the State.

6 9. Upon information and belief, Defendants will continue to register or acquire new
7 domain names for the purpose of selling goods bearing counterfeits of Tiffany's trademarks unless
8 preliminarily and permanently enjoined.


9 10. Defendants' Internet-based website businesses amount to nothing more than massive
10 illegal operations, infringing on the intellectual property rights of Tiffany and others.




11 11. Defendants use and have registered, established or purchased and maintained the
12 Subject Domain Names. Upon information and belief, Defendants have engaged in fraudulent
13 conduct with respect to the registration of the Subject Domain Names by providing false and/or
14 misleading information to their various Registrars during the Registration or maintenance process.
15 Upon information and belief, many of the Defendants have anonymously registered and maintained
16 some of the Subject Domain Names for the sole purpose of engaging in illegal counterfeiting
17 activities.

18 12. Defendants' business names, i.e., the Subject Domain Names and any other domain
19 names used in connection with the sale of counterfeits bearing Tiffany's trademarks are essential
20 components of Defendants' counterfeiting and infringing activities. The Subject Domain Names
21 themselves are the means by which Defendants further their counterfeiting scheme and cause harm
22 to Tiffany. Moreover, Defendants are using Tiffany's famous name and trademarks to drive Internet
23 consumer traffic to their websites operating under the Subject Domain Names, thereby creating and
24 increasing the value of the Subject Domain Names at Tiffany's expense.

COMMON FACTUAL ALLEGATIONS

13. Tiffany is the owner and/or exclusive licensee of all rights in and to the following trademarks which are valid and registered on the Principal Register of the United States Patent and Trademark Office:

14 (the “Tiffany Marks”) which are used in connection with the manufacture and distribution of high
15 quality goods in the categories identified above.

16 14. The Tiffany Marks have been used in interstate commerce to identify and distinguish
17 Tiffany's high quality jewelry, including bracelets, necklaces, pendants, earrings and rings, cufflinks,
18 money clips, key rings, watches, and gift boxes, and other goods for an extended period of time.

19 15. The Tiffany Marks have never been assigned or licensed to any of the Defendants in
20 this matter.

21 16. The Tiffany Marks are symbols of Tiffany's quality, reputation and goodwill and have
22 never been abandoned.

23 17. Further, Tiffany has expended substantial time, money and other resources
24 developing, advertising and otherwise promoting the Tiffany Marks. The Tiffany Marks qualify as
25 famous marks as that term is used in 15 U.S.C. §1125(c)(1).

1 bearing trademarks which are exact copies or colorable imitations of the Tiffany Marks (the
2 “Defendants’ Goods”). Specifically, upon information and belief, Defendants are using the Tiffany
3 Marks for different quality goods.

4 24. The Defendants’ Goods are of a quality substantially different than that of Tiffany’s
5 genuine goods. Despite the nature of the Defendants’ Goods and the knowledge they are without
6 authority to do so, Defendants are actively using, promoting and otherwise advertising, distributing,
7 selling and/or offering for sale substantial quantities of such goods with the knowledge that such
8 goods will be mistaken for the genuine high quality products offered for sale by Tiffany. The net
9 effect of Defendants’ actions will be to result in the confusion of consumers at the time of initial
10 interest, sale and in the post-sale setting, who will believe Defendants’ Goods are genuine goods
11 originating from, associated with, and approved by Tiffany.

12 25. Defendants advertise their products for sale to the consuming public. In so advertising
13 these products, Defendants improperly and unlawfully use the Tiffany Marks. Upon information
14 and belief, the misappropriation of the Tiffany Marks has been the proximate cause of harm to
15 Tiffany.

16 26. As part of their overall infringement and counterfeiting scheme, the Defendants are,
17 upon information and belief, all employing substantially similar, and often times coordinated, SEO
18 strategies based, in large measure, upon an illegal use of counterfeits of the Tiffany Marks.
19 Specifically, the Defendants are using counterfeits of Tiffany’s name and the Tiffany Marks in order
20 to make their websites selling illegal goods appear more relevant and attractive to search engines
21 across an array of search terms. By their actions, the Defendants are causing concurrent and
22 indivisible harm to Tiffany and the consuming public by (i) depriving Tiffany and other third parties
23 of the ability to fairly compete for space within search engine results, (ii) causing an overall
24 degradation of the value of the goodwill associated with the Tiffany Marks and (iii) increasing
25 Tiffany’s overall cost to market its goods and educate consumers about the brand via the Internet.

26 27. Upon information and belief, Defendants are concurrently conducting their
27 counterfeiting and infringing activities at least within this Judicial District and elsewhere throughout
28

1 the United States. As a result, Defendants are defrauding Tiffany and the consuming public for
2 Defendants' own benefit. Defendants' infringement and disparagement of Tiffany does not simply
3 amount to the wrong description of their goods or the failure of the goods to conform to the
4 advertised quality or performance.

5 28. Defendants' use of the Tiffany Marks, including the promotion and advertisement,
6 reproduction, distribution, sale and offering for sale of their Defendants' Goods, is without Tiffany's
7 consent or authorization.

8 29. Further, Defendants are engaging in the above-described illegal counterfeiting and
9 infringing activities knowingly and intentionally or with reckless disregard or willful blindness to
10 Tiffany's rights for the purpose of trading on the goodwill and reputation of Tiffany.

11 30. Defendants' above-identified infringing activities are likely to cause confusion,
12 deception and mistake in the minds of consumers, the public and the trade. Moreover, Defendants'
13 wrongful use of the Tiffany Marks is likely to create a false impression and deceive customers, the
14 public and the trade into believing there is a connection or association between Tiffany and
15 Defendants' Goods.

16 31. Tiffany has no adequate remedy at law.

17 32. Tiffany is suffering irreparable and indivisible injury and damages as a result of
18 Defendants' unauthorized and wrongful use of the Tiffany Marks. If Defendants' counterfeiting,
19 infringing and unfairly competitive activities are not preliminarily and permanently enjoined by this
20 Court, Tiffany and the consuming public will continue to be harmed.

21 33. The injuries and damages sustained by Tiffany have been directly and proximately
22 caused by Defendants' wrongful reproduction, use, advertisement, promotion, offering to sell, and
23 sale of Defendants' Goods.

24 34. Tiffany has retained the undersigned counsel to represent it in this matter and is
25 obligated to pay said counsel a reasonable fee for such representation.

COUNT I - TRADEMARK COUNTERFEITING AND INFRINGEMENT

1
2 35. Tiffany hereby re-adopts and re-alleges the allegations set forth in Paragraphs 1
3 through 34 above.

4 36. This is an action for trademark counterfeiting and infringement against Defendants
5 based on their use of counterfeits, copies and/or colorable imitations of the Tiffany Marks in
6 commerce in connection with the promotion, advertisement, distribution, sale and/or offering for
7 sale of the Defendants' Goods.

8 37. Specifically, Defendants are promoting and otherwise advertising, selling, offering
9 for sale and distributing at least counterfeit and/or infringing bracelets, necklaces, pendants, earrings
10 and rings, cufflinks, money clips, key rings, watches, and gift boxes bearing the Tiffany Marks.
11 Defendants are continuously infringing and inducing others to infringe the Tiffany Marks by using
12 them to advertise, promote and sell at least counterfeit and/or infringing jewelry, including bracelets,
13 necklaces, pendants, earrings and rings, cufflinks, money clips, key rings, watches, and gift boxes.

14 38. Defendants' concurrent counterfeiting, infringing and unfairly competitive activities
15 are likely to cause and, upon information and belief, actually are causing confusion, mistake and
16 deception among members of the trade and the general consuming public as to the origin and quality
17 of Defendants' Goods bearing or sold using the Tiffany Marks.

18 39. Defendants' unlawful actions have caused and are continuing to cause unquantifiable
19 and irreparable harm to Tiffany.

20 40. Defendants' above-described illegal actions constitute counterfeiting and
21 infringement of the Tiffany Marks in violation of Tiffany's rights under § 32 of the Lanham Act, 15
22 U.S.C. § 1114.

23 41. Tiffany has suffered and will continue to suffer irreparable injury due to the above
24 described activities of Defendants if Defendants are not preliminarily and permanently enjoined.

COUNT II - FALSE DESIGNATION OF ORIGIN

PURSUANT TO § 43(a) OF THE LANHAM ACT

3 42. Tiffany hereby re-adopts and re-alleges the allegations set forth in Paragraphs 1
4 through 34 above.

5 43. Defendants' Goods bearing and sold under the Tiffany Marks have been widely
6 advertised and distributed throughout the United States.

7 44. Defendants' Goods bearing and sold under the Tiffany Marks are virtually identical in
8 appearance to each of Tiffany's respective genuine goods. However, the Defendants' Goods are
9 different in quality. Accordingly, Defendants' activities are likely to cause confusion in the trade and
10 among the general public as to at least the origin or sponsorship of the Defendants' Goods.

11 45. Defendants, upon information and belief, have used in connection with their sale of
12 products, false designations of origins and false descriptions and representations, including words or
13 other symbols and trade dress which tend to falsely describe or represent such goods and have
14 caused such goods to enter into commerce with full knowledge of the falsity of such designations of
15 origin and such descriptions and representations, all to the detriment of Tiffany.

16 46. Specifically, Defendants have authorized an infringing use of the Tiffany Marks, in
17 Defendants' advertisement and promotion of their counterfeit and infringing jewelry, including
18 bracelets, necklaces, pendants, earrings and rings, cufflinks, money clips, key rings, watches, and
19 gift boxes. Defendants have also misrepresented to members of the consuming public that the
20 products being advertised and sold by them are genuine, non-infringing products.

21 47. Additionally, Defendants are using counterfeits of the Tiffany Marks in order to
22 unfairly compete with Tiffany and others for space within search engine organic results, thereby
23 jointly depriving Tiffany of a valuable marketing and educational tool which would otherwise be
24 available to Tiffany.

25 48. Defendants' above-described actions are in violation of Section 43(a) of the Lanham
26 Act, 15 U.S.C. §1125(a).

1 49. Tiffany has sustained indivisible injury and harm caused by Defendants' concurrent
2 conduct, and absent an entry of an injunction by this Court, Tiffany will continue to suffer
3 irreparable injury to its goodwill and business reputation as well as monetary damages.

4 **COUNT III - CLAIM FOR RELIEF FOR CYBERPIRACY**

5 **UNDER §43(d) OF THE LANHAM ACTION, 15 U.S.C. §1125(d)**

6 50. Tiffany hereby re-adopts and re-alleges the allegations set forth in Paragraphs 1
7 through 34 above.

8 51. At all times relevant hereto, Tiffany has been and still is the owner of the rights, title
9 and interest in and to the Tiffany Marks.

10 52. Upon information and belief, Defendants have acted with the bad faith intent to profit
11 from the Tiffany Marks and the goodwill associated with the Tiffany Marks by registering various
12 domain names which are identical or confusingly similar to or dilutive of the Tiffany Marks.

13 53. Defendants have no intellectual property rights in or to the Tiffany Marks.

14 54. Defendants' actions constitute cyberpiracy in violation of §43(d) of the Lanham Act,
15 15 U.S.C. §1125(d).

16 55. Defendants' conduct is done with knowledge and constitutes a willful violation of
17 Tiffany's rights in the Marks. At a minimum, Defendants' conduct constitutes reckless disregard for
18 and willful blindness to Tiffany's rights.

19 56. The aforesaid conduct is causing Tiffany damages and immediate and irreparable
20 injury. Tiffany has no adequate remedy at law.

21 **COUNT IV - COMMON LAW UNFAIR COMPETITION**

22 57. Tiffany hereby re-adopts and re-alleges the allegations set forth in Paragraphs 1
23 through 34 above.

24 58. This is an action against Defendants based on their manufacture, promotion,
25 advertisement, distribution, sale and/or offering for sale of goods bearing marks which are virtually
26 identical, both visually and phonetically, to the Tiffany Marks in violation of Nevada's common law
27 of unfair competition.

1 bracelets, necklaces, pendants, earrings and rings, cufflinks, money clips, key rings, watches, and
2 gift boxes, and other goods; from affixing, applying, annexing or using in connection with the sale of
3 any goods, a false description or representation, including words or other symbols tending to falsely
4 describe or represent Defendants' goods as being those of Tiffany, or in any way endorsed by
5 Tiffany and from offering such goods in commerce; from engaging in search engine optimization
6 strategies using colorable imitations of the Tiffany name or Marks; and from otherwise unfairly
7 competing with Tiffany.

8 b. Entry of an Order that, upon Tiffany's request, those in privity with
9 Defendants, and those with notice of the injunction, including any Internet search engines, Web
10 hosts, domain-name registrars and domain-name registries or their administrators that are provided
11 with notice of the injunction, cease facilitating access to any or all domain names and websites
12 through which Defendants engage in the sale of counterfeit and infringing goods using the Tiffany
13 Marks.

14 c. Entry of an Order that, upon Tiffany's request, the top level domain (TLD)
15 Registries for the Subject Domain Names and their administrators place the Subject Domain Names
16 on Registry Hold status, thus removing them from the TLD zone files maintained by the Registries
17 which link the Subject Domain Names to the IP addresses where the associated websites are hosted.

18 d. Entry of an order canceling or, at Tiffany's election, transferring the Subject
19 Domain Names and any other domain names used by the Defendants to engage in their
20 counterfeiting of the Tiffany Marks at issue to Tiffany's control so they may no longer be used for
21 illegal purposes.

22 e. Entry of an order that, upon Tiffany's request, the Internet Corporation for
23 Assigned Names and Numbers ("ICANN") shall take all actions necessary to ensure that the top
24 level domain Registries responsible for the Subject Domain Names transfer and/or disable the
25 Subject Domain Names as directed by the Court.

1 f. Entry of an award of Tiffany's costs and reasonable attorneys' fees and
2 investigative fees associated with bringing this action.

3 g. Entry of further relief as the Court may deem just and proper.
