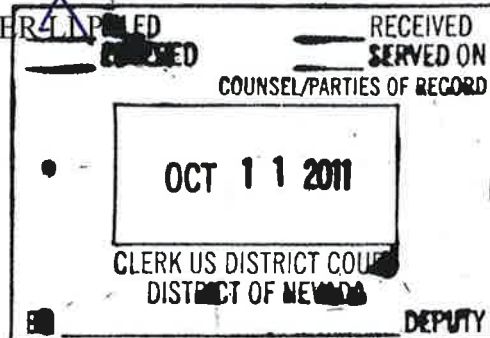

[PROPOSED] ORDER GRANTING
PLAINTIFF'S SECOND APPLICATION
FOR ENTRY OF PRELIMINARY
INJUNCTION

23
24 THIS CAUSE is before the Court on Plaintiff's Second Application For Entry of Preliminary
25 Injunction (the "Second Application for Preliminary Injunction") (#54), and upon the Preliminary
26 Injunction Hearing held on October 11, 2011. The Court has carefully reviewed said Motion, the
27 entire court file and is otherwise fully advised in the premises.

1 By the instant Application (# 54), Plaintiff Tiffany (NJ), LLC (“Tiffany”), moves for entry of
2 a preliminary injunction against Defendants 224 – 389, The Partnerships and Unincorporated
3 Associations identified on Schedule “A” hereto (collectively the “Group III Defendants”) for alleged
4 violations of the Lanham Act, 15 U.S.C. §§ 1114, and 1125(a) and (d).

5 The Court convened the hearing on October 11, 2011, at which only counsel for Plaintiff was
6 present and available to present evidence supporting the Second Application for Preliminary
7 Injunction (#54). Defendants have not responded to the Second Application for Preliminary
8 Injunction, nor made any filing in this case, nor have Defendants appeared in this matter either
9 individually or through counsel. Because Plaintiff has satisfied the requirements for the issuance of a
10 preliminary injunction, the Court will grant Plaintiff’s Second Application for Preliminary Injunction
11 (#54).

12 **I. Factual and Procedural Background**

13 On September 27, 2011, the Court entered a temporary restraining order on the following
14 facts from Plaintiff’s Complaint, First Amended Complaint, Second *Ex Parte* Application for Entry
15 of a Temporary Restraining Order and Preliminary Injunction, and supporting evidentiary
16 submissions.

17 Tiffany is a Delaware limited liability company with its principal place of business in the
18 United States located at 15 Sylvan Way, Parsippany, NJ 07054. (First Am. Compl. ¶ 3.) Tiffany is
19 engaged in the manufacture, promotion, distribution, and sale in interstate commerce, including
20 within this Judicial District, of high quality products under Tiffany’s trademarks. (Declaration of
21 Steven Costello in Support of Plaintiff’s Second *Ex Parte* Application for Entry of Temporary
22 Restraining Order and Preliminary Injunction [“Costello Decl.”] ¶ 5.)



23 Tiffany is, and at all times relevant hereto has been, the owner and/or exclusive licensee of
24 all rights in and to the following trademarks (the “Tiffany Marks”):

The Tiffany Marks are used in connection with the manufacture and distribution of high quality goods in the categories identified above. (Costello Decl. ¶ 4; *see also* United States Trademark Registrations of the Tiffany Marks at issue [“Tiffany Trademark Registrations”] attached as Exhibit A to the Declaration of Steven Costello In Support of Plaintiff’s *Ex Parte* Application for Temporary Restraining Order dated April 12, 2011 (D.E. 5-2 and 5-3), incorporated herein by reference).

The Group III Defendants have advertised, offered for sale, and/or sold at least jewelry, including bracelets, necklaces, pendants, earrings and rings, cufflinks, money clips, key holders, watches, and gift boxes, bearing what Plaintiff has determined to be counterfeits, reproductions, and/or colorable imitations of the Tiffany Marks. Although each of the Group III Defendants may not copy and infringe each Tiffany Mark for each category of goods protected, Tiffany has submitted sufficient evidence showing each Group III Defendant has infringed at least one or more of the Tiffany Marks. (Costello Decl. ¶¶ 11-15; Declaration of Danilo Marquez in Support of Plaintiff’s Second *Ex Parte* Application for Entry of Temporary Restraining Order and Preliminary Injunction [“Marquez Decl.”] ¶ 4.) The Group III Defendants are not now, nor have they ever been, authorized or licensed to use, reproduce, or make counterfeits, reproductions, and/or colorable imitations of the Tiffany Marks. (Costello Decl. ¶ 9.)

1 Plaintiff's counsel retained Danilo Marquez ("Marquez") of Investigative Consultants to
2 investigate suspected sales of counterfeit Tiffany branded products by the Group III Defendants.
3 (Costello Decl. ¶ 10; Marquez Decl. ¶ 3.) Between June 21, 2011 and June 27, 2011, Marquez
4 accessed the Internet websites operating under the domain names tiffanyreplica-outlet.com, tiffany-
5 replicas.com, tiffanyco-outlet.com, tiffany-accessories.com, and tiffanyjewelryoutlet.com, placed
6 orders for the purchase of two Tiffany branded key holders, a Tiffany branded bracelet, and two
7 Tiffany branded pendants, and requested each product purchased be shipped to his address in Las
8 Vegas, Nevada. (Marquez Decl. ¶ 4 and Composite Exhibit A attached thereto.) Marquez's
9 purchases were processed entirely online, which included providing shipping and billing
10 information, payment, and confirmation of his orders. (Marquez Decl. ¶ 4 and Composite Exhibit A
11 attached thereto.)

12 Thereafter, a representative of Tiffany, Steven Costello, reviewed and visually inspected the
13 web page listings, including images, for each of the Tiffany branded goods purchased by Marquez
14 and determined the items were non-genuine Tiffany products. (Costello Decl. ¶¶ 11, 12, 15.)
15 Additionally, Costello reviewed and visually inspected the items bearing the Tiffany Marks offered
16 for sale via the Internet websites operating under the partnership and/or unincorporated association
17 names identified on Schedule "A" hereto (the "Group III Subject Domain Names") and determined
18 the products were non-genuine Tiffany products. (Costello Decl. ¶ 13 and Composite Exhibit A
19 attached thereto, relevant web page captures from the Group III Defendants' Internet websites
20 operating under the Group III Subject Domain Names displaying the Tiffany branded items offered
21 for sale.)

22 On September 16, 2011, Plaintiff filed its First Amended Complaint (#53) and on September
23 23, 2011, filed its revised First Amended Complaint (#58) against the Group III Defendants for
24 trademark counterfeiting and infringement, false designation of origin, and cyberpiracy. On
25 September 19, 2011, Plaintiff filed its Second *Ex Parte* Application for Entry of a Temporary
26 Restraining Order and Preliminary Injunction (#54). On September 27, 2011, the Court issued an
27 Order Granting Plaintiff's Second *Ex Parte* Application for a Temporary Restraining Order and
28

1 temporarily restrained the Group III Defendants from infringing the Tiffany Marks at issue. Pursuant
2 to the Court's September 27, 2011 Order, Plaintiff provided Defendants notice and copies of the
3 Court's September 27, 2011 Order and Plaintiff's *Ex Parte* Application for Entry of a Temporary
4 Restraining Order and Preliminary Injunction and supporting papers via publication on the website
5 located at <http://servingnotice.com/off/index.html>, via email to the email address reflected in the
6 domain registration data for the Subject Domain Names, and/or via email to the registrar of record
7 for each of the Subject Domain Names.

8 **II. Conclusions of Law**

9 The declarations and supporting evidentiary submissions Plaintiff submitted in support of its
10 Second Application for Preliminary Injunction support the following conclusions of law:

11 A. Plaintiff has a very strong probability of proving at trial that consumers are likely to
12 be confused by the Group III Defendants' advertisement, promotion, sale, offer for sale, and/or
13 distribution of jewelry, including bracelets, necklaces, pendants, earrings and rings, cufflinks, money
14 clips, key holders, watches, and gift boxes bearing counterfeits, reproductions, and/or colorable
15 imitations of the Tiffany Marks, and that the products the Group III Defendants are selling are copies
16 of Plaintiff's products that bear marks which are substantially indistinguishable from and/or colorful
17 imitations of the Tiffany Marks on jewelry, including bracelets, necklaces, pendants, earrings and
18 rings, cufflinks, money clips, key holders, watches, and gift boxes.

19 B. Because of the infringement of the Tiffany Marks, Plaintiff is likely to suffer
20 immediate and irreparable injury if a preliminary injunction is not granted. It clearly appears from
21 the following specific facts, as set forth in Plaintiff's First Amended Complaint, Plaintiff's Second
22 Application for Preliminary Injunction, and accompanying declarations on file, that immediate and
23 irreparable loss, damage, and injury will result to Plaintiff and to consumers because it is more likely
24 true than not that:

25 1. The Group III Defendants appear to be operating Internet business operations
26 which advertise, promote, offer for sale, and sell, at least, jewelry, including bracelets, necklaces,
27

1 pendants, earrings and rings, cufflinks, money clips, key holders, watches, and gift boxes bearing
2 counterfeit and infringing trademarks in violation of Plaintiff's rights;

3 2. Plaintiff has well-founded fears that more counterfeit and infringing jewelry,
4 including bracelets, necklaces, pendants, earrings and rings, cufflinks, money clips, key holders,
5 watches, and gift boxes bearing Plaintiff's trademarks will appear in the marketplace; that consumers
6 may be misled, confused, and disappointed by the quality of these products; and that Plaintiff may
7 suffer loss of sales for its genuine products;

8 3. Plaintiff has well-founded fears that unless the injunction is granted, the
9 Group III Defendants can easily and quickly transfer the registrations for many of the Group III
10 Subject Domain Names, or modify registration data and content, change hosts, and redirect traffic to
11 other websites, thereby thwarting Plaintiff's ability to obtain meaningful relief;

12 4. The balance of potential harm to the Group III Defendants in restraining their
13 trading in counterfeit and infringing branded goods if a preliminary injunction is issued is far
14 outweighed by the potential harm to Plaintiff, its reputation and goodwill as a manufacturer of high
15 quality jewelry, including bracelets, necklaces, pendants, earrings and rings, cufflinks, money clips,
16 key holders, watches, and gift boxes, if such relief is not issued; and

17 5. The public interest favors issuance of the preliminary injunction in order to
18 protect Plaintiff's trademark interests and the public from being defrauded by the palming off of
19 counterfeit goods as Plaintiff's genuine goods.

20 Accordingly, after due consideration, it is

21 ORDERED AND ADJUDGED that Plaintiff's Second Application for Entry of a
22 Preliminary Injunction (#54) hereby is **GRANTED** as follows:

23 (1) The Group III Defendants, their officers, directors, employees, agents, subsidiaries,
24 distributors, and all persons in active concert or participation with the Group III Defendants having
25 notice of this Second Preliminary Injunction are hereby restrained and enjoined, pending termination
26 of this action:

1 (a) From manufacturing, importing, advertising, promoting, offering to sell,
2 selling, distributing, or transferring any products bearing the Tiffany Marks,
3 or any confusingly similar trademarks, other than those actually manufactured
4 or distributed by Plaintiff; and

5 (b) From secreting, concealing, destroying, selling off, transferring, or otherwise
6 disposing of: (i) any products, not manufactured or distributed by Plaintiff,
7 bearing the Tiffany Marks, or any confusingly similar trademarks; or (ii) any
8 evidence relating to the manufacture, importation, sale, offer for sale,
9 distribution, or transfer of any products bearing the Tiffany Marks, or any
10 confusingly similar trademarks.

11 (2) The Group III Defendants, their officers, directors, employees, agents, subsidiaries,
12 distributors, and all persons in active concert or participation with the Group III Defendants having
13 notice of this Second Preliminary Injunction shall, until the conclusion of this action, discontinue the
14 use of the Tiffany Marks or any confusingly similar trademarks, on or in connection with all Internet
15 websites owned and operated, or controlled by them including the Internet websites operating under
16 the Group III Subject Domain Names;

17 (3) The Group III Defendants, their officers, directors, employees, agents, subsidiaries,
18 distributors, and all persons in active concert or participation with the Group III Defendants having
19 notice of this Second Preliminary Injunction shall, until the conclusion of this action, discontinue the
20 use of the Tiffany Marks, or any confusingly similar trademarks within domain name extensions,
21 metatags or other markers within website source code, from use on any webpage (including as the
22 title of any web page), any advertising links to other websites, from search engines' databases or
23 cache memory, and any other form of use of such terms which is visible to a computer user or serves
24 to direct computer searches to websites registered by, owned, or operated by the Group III
25 Defendants, including the Internet websites operating under the Group III Subject Domain Names;

26 (4) The Group III Defendants shall not transfer ownership of the Group III Subject
27 Domain Names during the pendency of this Action, or until further Order of the Court;

1 (5) The domain name Registrars for the Group III Subject Domain Names are directed, to
2 the extent it is not already done, to lock the Group III Subject Domain Names and deliver to
3 Plaintiff's counsel, for deposit with this Court, domain name certificates for the Group III Subject
4 Domain Names;

5 (6) The Registrars and the top-level domain (TLD) Registries for the Group III Subject
6 Domain Names, upon receipt of this Second Preliminary Injunction shall, to the extent it is not
7 already done, change or assist in changing, the Registrar of record for the Group III Subject Domain
8 Names, excepting any such domain names which such Registries have been notified in writing by
9 the Plaintiff have been or will be dismissed from this action, to a holding account with the United
10 States based Registrar, GoDaddy.com, Inc. GoDaddy.com, Inc. shall hold and/or continue to hold
11 the Group III Subject Domain Names in trust for the Court during the pendency of this action.
12 Additionally, GoDaddy.com, Inc., upon receipt of this Order, shall, to the extent not already done,
13 immediately update and/or not modify the Domain Name System ("DNS") data it maintains for the
14 Group III Subject Domain Names, which link the domain names to the IP addresses where their
15 associated websites are hosted, from NS1.MEDIATEMPLE.NET and NS2.MEDIATEMPLE.NET,
16 which currently causes the domain names to resolve to the website where copies of the Complaint,
17 First Amended Complaint, Summonses, and Orders, and all other documents on file in this action are
18 displayed. Alternatively, GoDaddy.com, Inc. may, to the extent not already done, institute and/or
19 maintain a domain name forwarding which will automatically redirect any visitor to the Group III
20 Subject Domain Names to the following Uniform Resource Locator ("URL")
21 <http://servingnotice.com/off/index.html> whereon copies of the Complaint, First Amended Complaint,
22 Summonses, and Orders, and other documents on file in this action are displayed. The Group III
23 Subject Domain Names shall be maintained on Lock status, preventing the modification or deletion
24 of the domains by the registrar or the Group III Defendants;

25 (7) Plaintiff may continue to enter the Group III Subject Domain Names into Google's
26 Webmaster Tools and cancel any redirection of the domains that have been entered there by the
27

1 Group III Defendants which redirect traffic to the counterfeit operations to a new domain name and
2 thereby evade the provisions of this Second Preliminary Injunction;

3 (8) The Group III Defendants shall continue to preserve copies of all their computer files
4 relating to the use of any of the Group III Subject Domain Names and shall continue to take all steps
5 necessary to retrieve and preserve computer files relating to the use of any of the Group III Subject
6 Domain Names and that may have been deleted before the entry of this Second Preliminary
7 Injunction;


8 (9) Plaintiff shall maintain its bond in the amount of Twenty-Thousand Dollars and Zero
9 Cents (\$20,000.00), as payment of damages to which the Group III Defendants may be entitled for a
10 wrongful injunction or restraint, during the pendency of this action, or until further Order of the
11 Court;

12 (10) This Second Preliminary Injunction shall remain in effect during the pendency of this
13 action, or until such further date as set by the Court or stipulated to by the parties;

14 (11) This Second Preliminary Injunction shall apply to the Group III Subject Domain
15 Names and any other domain names properly brought to the Court's attention by affidavit which
16 verifies such new domain names are being used by the Group III Defendants for the purpose of
17 counterfeiting the Tiffany Marks at issue in this action and/or unfairly competing with Tiffany in
18 connection with search engine results pages.

19 IT IS SO ORDERED.
