PAPERLESS ORDER Setting Hearing on [47] Plaintiff's Motion for Extension of Time to File Notice of Compliance. Plaintiff's motion [47] implicitly suggests that it demonstrated good cause for enlarging the time in which to file a notice of compliance after the deadline expired. But no actual basis for the good cause argument was provided. Moreover, the attorney who appears to have missed the Court-ordered deadline also was required to recently submit materials which should have been filed in another, similar case. Specifically, in *Addidas AG v. aakicks.com, et al*, Case No. 25-cv-21495 Williams/Goodman, the Undersigned entered an Order today which noted that none of the certificates of service reflect that a copy of the Amended Complaint for Injunctive Relief was served on Defendants, and the pleading itself does not include a certificate of service. The Undersigned entered an Order requiring that Plaintiff file the necessary confirmation. The same attorney is involved in both cases.

Given this background, the Court will schedule an in-person hearing on the motion [47], for Friday, April 18, 2025, at 10:30 a.m. Lead counsel for Plaintiff in both cases, Stephen Gaffigan, must attend. In addition, the attorney who seems to be handling the day-to-day tasks on both cases, Virgilio Gigante, must also
