**FINAL JUDGMENT**

**THIS CAUSE** came before the Court upon Plaintiff, Goyard' St-Honore's Motion for . . . Default Final Judgment [ECF No. 38], filed on December 30, 2025. For the reasons set forth in the Court's Order [ECF No. 42] granting the Motion, it is

**ORDERED AND ADJUDGED** as follows:

1. Judgment is entered in favor of Plaintiff and against Defendants, the Individuals, Business Entities, or Unincorporated Associations identified on Schedule "A" to Plaintiff's Amended Complaint [ECF No. 14].

2. Permanent Injunctive Relief. Each Defendant, its officers, directors, employees, agents, subsidiaries, distributors, and attorneys, and all persons in active concert or participation with any Defendant are permanently restrained and enjoined from:

a. manufacturing or causing to be manufactured, importing, advertising, or promoting, distributing, selling or offering to sell, or transferring any products bearing and/or using Plaintiff's trademarks, or any confusingly similar trademarks, identified in Paragraph 16 of Plaintiff's Amended Complaint (the "Goyard Marks");

b. using the Goyard Marks in connection with the sale of any unauthorized goods;

c. using any logo, trade name, trademark, design, and/or layout which may be calculated to falsely advertise the services or products of Defendants as being sponsored by, authorized by, endorsed by, or in any way associated with Plaintiff;

d. falsely representing themselves as being connected with Plaintiff, through sponsorship or association;

e. engaging in any act which is likely to falsely cause members of the trade and/or of the purchasing public to believe any goods or services of Defendants are in any way endorsed by, approved by, and/or associated with Plaintiff;

f. using any reproduction, counterfeit, copy, or colorable imitation of the Goyard Marks in connection with the publicity, promotion, sale, or advertising of any goods sold by Defendants;

g. affixing, applying, annexing or using in connection with the sale of any goods, a false description or representation, including words or other symbols tending to falsely describe or represent goods offered for sale or sold by Defendants as being those of Plaintiff, or in any way endorsed by Plaintiff and from offering such goods in commerce;

h. otherwise unfairly competing with Plaintiff;

i. using Plaintiff's Marks, or any confusingly similar trademarks, within domain name extensions, metatags, or other markers within website source code, from use on any webpage (including as the title of any web page), in any advertising links to other websites, from search engines' databases or cache memory, and any other form of use of such terms which are visible to a computer user or serves to direct computer searches to Internet websites registered, owned, or operated by any Defendants; and

j. effecting assignments or transfers, forming new entities or associations or utilizing any other device for the purpose of circumventing or otherwise avoiding the prohibitions set forth above.

3. Additional Equitable Relief.

a. To give practical effect to the Permanent Injunction, upon Plaintiff's request, the domain names identified on Schedule "A" hereto (the "Subject Domain Names") are hereby ordered to be immediately transferred by Defendants, their assignees and/or successors in interest or title, and the Registrars to Plaintiff's control. To the extent the current Registrars do not facilitate the transfer of the Subject Domain Names to Plaintiff's control within five (5) days of receipt of this Judgment, upon Plaintiff's request, the top level domain ("TLD") Registry for each of the Subject Domain Names, or their administrators, including backend registry operators or administrators, shall, within thirty (30) days, (i) change the Registrar of Record for the Subject Domain Names to a Registrar of Plaintiff's choosing, and that Registrar shall transfer the Subject Domain Names to Plaintiff, or (ii) place the Subject Domain Names on Registry Hold status for the life of the current registration, thus removing them from the TLD zone files maintained by the Registries which link the Subject Domain Names to the IP addresses where the associated websites are hosted;

b. Defendants, their agent(s) or assign(s), shall voluntarily assign in writing all rights, title, and interest, to their Subject Domain Names identified on Schedule "A" hereto to Plaintiff and, if within five (5) days of receipt of this Order, Defendants fail to make such an assignment, the Court shall order the act to be done by another person appointed by the Court at Defendants' expense, such as the Clerk of Court, pursuant to Federal Rule

of Civil Procedure 70(a); and

c. Defendants, their agent(s) or assign(s), shall instruct in writing all search engines to permanently delist or deindex the Subject Domain Names identified on Schedule “A” hereto and, if within five (5) days of receipt of this Order, Defendants fail to make such a written instruction, the Court shall order the act to be done by another person appointed by the Court at Defendants’ expense, such as the Clerk of Court, pursuant to Federal Rule of Civil Procedure 70(a).

4. Plaintiff is entitled to an award of statutory damages against each Defendant under 15 U.S.C. section 1117(c), for which let execution issue, as follows:

The Court has weighed the willful nature of Defendants' conduct alongside the need for deterrence and concludes that the award lies well within the statutory limits set by 15 U.S.C. section 1117(c).

5. Plaintiff is entitled to an award of statutory damages under 15 U.S.C. section 1117(d), for which let execution issue, as follows:

6. This judgment shall bear interest at the rate as prescribed by 28 U.S.C. section 1961 and shall be enforceable as prescribed by 28 U.S.C. sections 2001, et seq., 28 U.S.C. sections 3001–3307, and Federal Rule of Civil Procedure 69(a).


7. The bond posted by Plaintiff in the amount of \$10,000.00 is ordered to be released by the Clerk.
