FINAL DEFAULT JUDGMENT AND PERMANENT INJUNCTION

THIS CAUSE is before the Court upon Plaintiff's Motion for Entry of Final Default Judgment against Defendants (the "Motion") [DE 36], filed herein on December 13, 2021. The Court granted the Motion in an Order entered separately today. Pursuant to Federal Rule of Civil Procedure 58(a), the Court enters this separate final judgment.

Accordingly, it is **ORDERED AND ADJUDGED** that Final Default Judgment is hereby entered in favor of Plaintiff, Chanel, Inc. ("Plaintiff"), and against Defendants, the Individuals, Business Entities, or Unincorporated Associations identified on Schedule "A" hereto (collectively "Defendants") as follows:

(1) Permanent Injunctive Relief:

Defendants and their officers, directors, agents, representatives, subsidiaries, distributors, servants, employees and attorneys, and all persons acting in concert and participation with Defendants are hereby permanently restrained and enjoined from:

- a. manufacturing or causing to be manufactured, importing, advertising, or promoting, distributing, selling or offering to sell counterfeit and infringing goods bearing and/or using Plaintiff's trademarks, or any confusingly similar trademarks, identified in Paragraph 15 of the Amended Complaint (the "Chanel Marks");

- b. using the Chanel Marks in connection with the sale of any unauthorized goods;
- c. using any logo, and/or layout which may be calculated to falsely advertise the services or products of Defendants as being sponsored by, authorized by, endorsed by, or in any way associated with Plaintiff;
- d. falsely representing themselves as being connected with Plaintiff, through sponsorship or association;
- e. engaging in any act which is likely to falsely cause members of the trade and/or of the purchasing public to believe any goods or services of Defendants is in any way endorsed by, approved by, and/or associated with Plaintiff;
- f. using any reproduction, counterfeit, copy, or colorable imitation of the Chanel Marks in connection with the publicity, promotion, sale, or advertising of any goods sold by Defendants;
- g. affixing, applying, annexing or using in connection with the sale of any goods, a false description or representation, including words or other symbols tending to falsely describe or represent goods offered for sale or sold by Defendants as being those of Plaintiff or in any way endorsed by Plaintiff and from offering such goods in commerce;
- h. otherwise unfairly competing with Plaintiff;
- i. using the Chanel Marks or any confusingly similar trademarks, within domain name extensions, metatags or other markers within website source code, from use on any webpage (including as the title of any web page), from any advertising links to other websites, from search engines' databases or cache memory, and from any other form of use of such terms which are visible to a computer user or serves to direct computer searches to websites, Internet based e-commerce stores, photo albums, seller identities, private messaging accounts, or website businesses registered by, owned, or operated by Defendants, including the e-commerce stores, photo albums, and Internet websites operating under the Seller IDs and Subject Domain Names registered by, owned, or operated by Defendants; and
- j. effecting assignments or transfers, forming new entities or associations or utilizing any other device for the purpose of circumventing or otherwise avoiding the prohibitions set forth above.

(2) Additional Equitable Relief:

- a. In order to give practical effect to the Permanent Injunction, the domain names identified on Schedule “A” hereto (the “Subject Domain Names”) are hereby ordered to be immediately transferred by Defendant Numbers 41-44 and 46-73, their assignees and/or successors in interest or title, and the Registrars to Plaintiff’s control. To the extent the current Registrars do not facilitate the transfer of the Subject Domain Names to Plaintiff’s control within five (5) days of receipt of this Judgment, upon Plaintiff’s request, Defendant numbers 41-44 and 46-73 and the top level domain (TLD) Registry for each of the Subject Domain Names, or their administrators, including backend registry operators or administrators, shall, within thirty (30) days, (i) change the Registrar of Record for the Subject Domain Names to a Registrar of Plaintiff’s choosing, and that Registrar shall transfer the Subject Domain Names to Plaintiff, or (ii) place the Subject Domain Names on Registry Hold status for the life of the current registration, thus removing them from the TLD zone files maintained by the Registries which link the Subject Domain Names to the IP addresses where the associated websites are hosted;
- b. Defendants, their agent(s) or assign(s), shall assign all rights, title, and interest, to their Subject Domain Name(s) to Plaintiff and, if within five (5) days of receipt of this Order Defendants fail to make such an assignment, the Court shall order the act to be done by another person appointed by the Court at Defendants’ expense, such as the Clerk of Court, pursuant to Federal Rule of Civil Procedure 70(a);
- c. Defendants, their agent(s) or assign(s), shall instruct in writing all search engines to permanently delist or deindex the Subject Domain Name(s) and, if within five (5) days of receipt of this Order Defendants fail to make such a written instruction, the Court shall order the act to be done by another person appointed by the Court at Defendants’ expense, such as the Clerk of Court, pursuant to Federal Rule of Civil Procedure 70(a);
- d. Plaintiff may serve this injunction on any e-mail service provider with a request that the service provider permanently suspend the e-mail addresses which are or have been used by Defendants in connection with Defendants’ promotion, offering for sale, and/or sale of goods using counterfeits and/or infringements of the Chanel Marks;
- e. Upon Plaintiff’s request, Defendants shall request, in writing, permanent termination of any messaging services, Seller IDs, usernames, and social media accounts they own, operate, or control on any messaging service and social media platform;
- f. Upon Plaintiff’s request, any messaging service and Internet marketplace,

social media, and image hosting website operators and/or administrators for the Seller IDs, including but not limited to Alibaba.com Hong Kong Limited, which operates the AliExpress.com platform, Amazon.com, Inc., Instagram.com, Etsy, Inc., Szwego.com, Yupoo.com, ContextLogic, Inc., which operates the Wish.com website, Dunhuang Group, which operates the DHgate.com and DHpay.com platforms, and Camel FinTech Inc, shall permanently remove from the multiple platforms, which include, inter alia, a Direct platform, Group platform, Seller Product Management platform, Vendor Product Management platform, and Brand Registry platform, any and all listings and associated images of goods bearing and/or using counterfeits and/or infringements of the Chanel Marks via the e-commerce stores and Internet based photo albums operating under the Seller IDs, including but not limited to the listings and associated images identified by the “parent” and/or “child” Amazon Standard Identification Numbers (“ASIN”) on Schedule “A” hereto, and any other listings and images of goods bearing and/or using counterfeits and/or infringements of the Chanel Marks associated with any ASIN linked to the same sellers or linked to any other alias e-commerce stores, seller identification names, photo albums, user names, and private messaging accounts being used and/or controlled by Defendants to promote, offer for sale and/or sell goods bearing and/or using counterfeits and/or infringements of the Chanel Marks; and

- g. Upon Plaintiff’s request, Defendants and any Internet marketplace, social media, and image hosting website operators and/or administrators, who are in possession, custody, or control of Defendants’ goods bearing and/or using one or more of the Chanel Marks, including but not limited to Alibaba.com Hong Kong Limited, which operates the AliExpress.com platform, Amazon.com, Inc., Instagram.com, Etsy, Inc., Szwego.com, Yupoo.com, ContextLogic, Inc., which operates the Wish.com website, Dunhuang Group, which operates the DHgate.com and DHpay.com platforms, and Camel FinTech Inc, shall permanently cease fulfillment of and sequester those goods, and surrender those goods to Plaintiff.

(3) Statutory damages in favor of Plaintiff pursuant to 15 U.S.C. § 1117(c):

- a. Award Plaintiff damages of \$1,000,000.00 against each Defendant, for which let execution issue, based upon the Court’s finding that each Defendant infringed at least one trademark on one type of good. The Court considered both the willfulness of Defendants’ conduct and the deterrent value of the award imposed, and the award falls within the permissible statutory range of 15 U.S.C. § 1117(c).

(4) All funds currently restrained or held on account for all Defendants by all financial institutions, payment processors, banks, escrow services, money transmitters, or

marketplace platforms, including but not limited to, Alibaba.com Hong Kong Limited, which operates the AliExpress.com platform (“AliExpress”), Zhejiang Ant Small and Micro Financial Services Group Co., Ltd. (“Ant Financial Services”), AliPay (China) Internet Technology Co. Ltd., Alipay.com Co., Ltd., and Alipay Singapore E-Commerce Private Limited (collectively, “Alipay”), Amazon Payments, Inc. (“Amazon”), PayPal, Inc. (“PayPal”), Etsy, Inc. (“Etsy”), Stripe, Inc. (“Stripe”), ContextLogic, Inc., which operates the Wish.com website (“ContextLogic”), Dunhuang Group which operates the DHgate.com and DHPay.com platforms, Camel FinTech Inc, and their related companies and affiliates are to be immediately (within five (5) business days) transferred by the previously referred to financial institutions, payment processors, banks, escrow services, money transmitters, or marketplace platforms and by Defendants, to Plaintiff and/or Plaintiff’s counsel in partial satisfaction of the monetary judgment entered herein against each Defendant. All financial institutions, payment processors, banks, escrow services, money transmitters, or marketplace platforms, including but not limited to, AliExpress, Ant Financial Services, Alipay, Amazon, PayPal, Etsy, Stripe, ContextLogic, Dunhuang Group which operates the DHgate.com and DHPay.com platforms, Camel FinTech Inc, and their related companies and affiliates, shall provide to Plaintiff at the time the funds are released, a breakdown reflecting the (i) total funds restrained in this matter per Defendant; (ii) total chargebacks, refunds, and/or transaction reversals deducted from each Defendant’s funds restrained prior to release; and (iii) the total funds released per Defendant to Plaintiff.

- (5) Interest from the date this action was filed shall accrue at the legal rate. See 28 U.S.C. § 1961.
- (6) The bond posted by Plaintiff in the amount of \$10,000.00 is hereby ordered released by the Clerk.
- (7) The Court retains jurisdiction to enforce this Judgment and permanent injunction
- (8) Plaintiff is ordered to serve a copy of this Order upon Defendants via e-mail to the e-mail accounts provided by Defendants as part of the data related to its e-commerce store, photo album, or domain name, including customer service e-mail addresses and onsite contact forms, or via the e-commerce marketplace, social media, or image hosting website e-mail for each of the e-commerce stores and photo albums, including private messaging applications and/or services, or via the registrars of record for the domain names; and by publicly posting a true and accurate copy of the foregoing on Plaintiff's Website appearing at <http://servingnotice.com/cs3Lf/index.html>.
- (9) The Clerk is directed to **CLOSE** this case and **DENY AS MOOT** any pending motions.
